

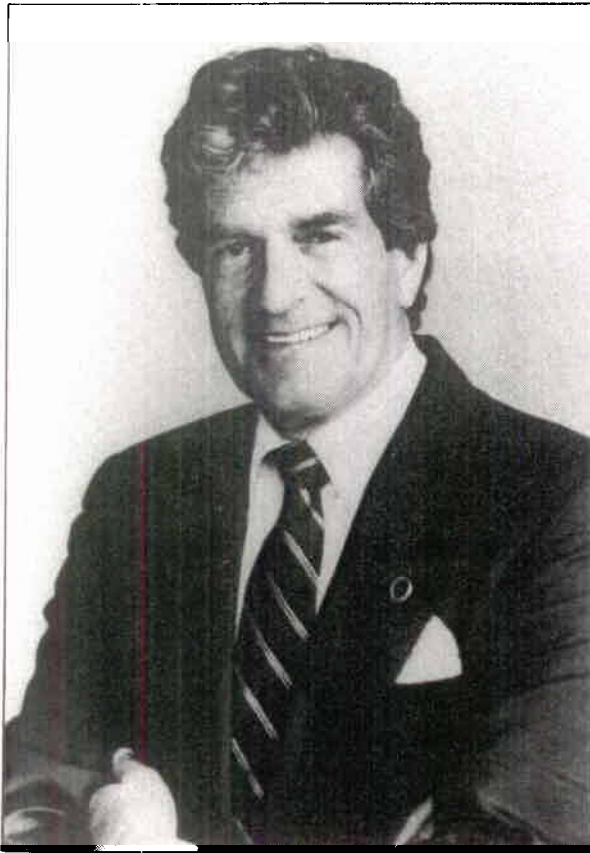

Jessica Laufer founded Laufer Associates in 1987 after more than a decade of public relations experience, including experience in designing and implementing national public outreach campaigns. Ms. Laufer has spearheaded national and regional public information campaigns on issues including solid waste disposal, AIDS education, cancer prevention, and child health. She has also designed national consumer marketing campaigns for major pharmaceutical companies and health care product companies. Ms. Laufer was a 1991 and 1992 finalist for Inc. magazines' "Entrepreneur of the Year" award and, also in 1991, was named a "Volunteer of the Year" by the Los Angeles Center for Nonprofit Management. She is also a past Executive Vice President and Board member of Women In Communications, Inc., Los Angeles. Ms. Laufer earned a master of arts degree from Harvard University with honors, and a bachelor of arts degree from Brandeis University and Harvard University, cum laude.

Richard J. Stegemeier, Chairman of the Board, Unocal Corporation.

Mr. Stegemeier joined Unocal in 1951 as a research engineer. In 1961, he became an engineer in the natural gas department. After two years in Tokyo, he went on to hold increasingly important operational responsibilities in petroleum exploration and production in California and the Far East before taking charge of the company's research division in 1978. In 1980, he became senior vice president of corporate development, and a member of Unocal's Board on Directors. He became president and chief operating officer in 1985, and president and chief executive officer on July 1, 1988. He was elected chairman of the board on April 24, 1989. Mr. Stegemeier is involved in numerous professional organizations and is a member of the U.S. Secretary of Energy's Advisory Board, and the National Petroleum Council. Mr. Stegemeier has been involved in many community organizations having served as a member of the Board of Governors of Town Hall of California, the Business Roundtable, and the Council on Foreign Relations. He has also served as the Chairman of the Board of Trustees of the Hugh O'Brian Youth Foundation. He has also served as a Board Member of the Archdiocese Foundation and is a member of the Board of Overseers of the Executive Council on Foreign Diplomats and the Huntington Library, Art Collections and Botanical Gardens. Mr. Stegemeier and his wife, Marjorie, live in Anaheim. They have four children and five grandchildren.

Ms. Wachtell received a B.A., Summa Cum Laude from Connecticut College and an M.A. from Cornell University. Ms. Wachtell serves on several Board of Directors including the Hugh O'Brian Youth Foundation, American Council for the Arts, California Community Foundation and the Los Angeles Visitors and Convention Bureau. Ms. Wachtell has been recognized for her community achievements and volunteer contribution from Big Sisters of Los Angeles. She received the Woman of Distinction by Soroptimist International, and the Leadership & Achievement Award from the Central City Association.

Robert Kresser, Chairman, Kresser/Craig Agency.

Mr. Kresser is a native of Pasadena and currently resides in Manhattan Beach. He received his B.A. from University of California/Berkeley. At age 34 he started his own ad agency, Kresser/Robbins. The agency was building momentum when Bud Robbins died suddenly in June 1984. He joined forces with Jean Craig in 1985 who had been a top copy writer at Foote Cone & Belding, later formed her own agency and had also lost a partner. They made the agency successful by taking the "approach from day one that they were the quintessential sleeves-rolled up/down-in-the-trenches agency working with their clients. The agency won the "Leader of the Year" award from the Western States Association of Advertising Agencies in 1991 for its pro bono and community involvements. Sports dominate Mr. Kresser non-business hour. Two-man beach volleyball is his favorite pastime. Mr. and Mrs. Kresser are the parents of three sons.

David L. Ross, President, David L. Ross Associates.

David L. Ross, who founded David L. Ross Associates in 1986 is a third generation Los Angeles native, grandson of silent film star Harold Lloyd. The path to his communications consulting business has enjoyed many turns: he owned and operated a candle company in an upstate NY commune; he ranged from bluegrass to classical in his performing interests; and ran a farm. He produced music videos with Lionel Richie, Linda Rondstadt, Jackson Browne and others. This diversity of experience contributes to his work helping people transform guarded, formal, and "scripted" communication styles into real, direct, and involved communications.

Colin Shepherd, Sr. Vice President, Hines Interests.

Mr. Shepherd joined Hines Interests in 1982 after receiving his M.B.A. from the Sloan School of Management at Massachusetts Institute of Technology. He also received his bachelors degree in Civil Engineering and Construction Management from MIT. During his twelve years at Hines, Mr. Shepherd has developed over 3 million square feet of office space and has been responsible for all areas of the development process. Mr. Tyson's work has a dual focus: 1) actively managing investment portfolios; and 2) where appropriate, guiding clients (and their families) through the personal challenges -- the hopes, fears, and illusions -- that accompany the quest for money and financial security. Mr. Tyson has presented investment management issues to various industry groups including the NFL and NBA players' agents and at UCLA-sponsored seminars on "Tax and Financial Planning for the Entertainment Industry." Mr. Tyson is also the Chairman of Bringing Up Baby, Inc., a company providing services, products, and educational classes to parent of newborn babies. Brad Johnson, Owner, Georgia Restaurant

Brad Johnson, the son of a renown New York restaurateur, was educated at the University of Massachusetts at Amherst, where he studied hotel and restaurant management while on a basketball scholarship. He became known on the social scene as a result of his fashion modeling and his business exposure. His entree into the restaurant business was in the dishroom of his father's restaurant, The Cellar, after he decided not to pursue a professional basketball career in Europe. In 1984, Brad had the opportunity to open his own restaurant with a friend, actor Al Corley of "Dynasty" fame. The restaurant, Memphis, was located on the upper West Side in Manhattan and was one of the first restaurants in New York to serve Cajun/New Orleans influenced food. The "Memphis" experience was important in exposing Brad to other elements of the industry including building construction, political climate, investor relations and city economics. He moved to Los Angeles in 1989 with his unique concept for a diverse restaurant/club and opened the very popular "Roxbury." His latest endeavor "Georgia" is located on Melrose Avenue and serves "southern hospitality and good wholesome 'down-home' food."

Robert Leach, C.E.O. Neo Biotech, Inc.

For the past 15 years Mr. Leach has been a leader in the biotechnology industry. He has lead three companies to develop innovative technologies and eventual purchase by larger concerns. The cornerstones of his career include commitment to the highest ethical standards, a commitment to people, and focus on the future. He created the second largest world-wide producer of genetically engineered products and lead a company with over 500 employees. For the first 13 years he built a career with Corning Glass Works. He likes to sail, play tennis, and camp with his family.

Donna White-Stanton, Presentation Consultant.

Ms. White-Stanton began her career as a stockbroker for Paine, Webber, Jackson, and Curtis and later as a sales representative for IBM. The demand for her services to assist professional individuals with their personal presentation within their industries increased. By observing how they might improve such aspects of their presentation as posture, stance, walk, breathing and overall appearance she was able to assist in the career development of her colleagues and clients. She has owned and operated a custom design apparel store, and currently consults to several industries in this fascinating profession.

Ms. Wheeler is the dynamic founder of a personal and professional development company which provides management training, corporate seminars and motivational speaking. Future of the United States: *"Will Term Limits Return Government to the People?"*

Cecilia Aguilera, Real Estate Attorney.

Ms. Aguilera was born in 1957 in Glendale, California. She is the eldest of five children. Spanish was her first language, learning English as a kindergartner at Glassell Park Elementary. She received her B.A. degree from UC Riverside in 1980. Until she began studying law at the UCLA school of Law in 1985, Ms. Aguilera worked in the legal and entertainment fields in varying capacities. While attending law school, she was a legal extern at the Director's Guild of America. Shortly after Ms. Aguilera's graduation in 1988, her interest focused on real estate. She joined Tooley & Company, a Los Angeles based full service real estate company, in 1990. In the ensuing three years, she held various positions in development and property management throughout the greater Los Angeles area as well as Orange County.

Linda Griego, President and C.E.O., Rebuild Los Angeles.

Ms. Griego is a successful business owner and former Deputy Mayor of Los Angeles. Born and raised in Tulum, Mexico, Griego comes from a Mexican-American family of bakers and railroad workers. In 1967, she moved to Washington, D.C., where she worked for her hometown Congressman, Thomas G. Morris. From 1969 through 1976, Griego worked for U.S. Senator Alan Cranston. She earned a bachelor's degree in history from UCLA in 1975. Ms. Griego was the first in her family to graduate from high school and college. In 1991, Ms. Griego was appointed by Mayor Tom Bradley as Deputy Mayor in charge of economic development. Ms. Griego was responsible for the oversight of a number of City departments, agencies and commissions, including the Community Redevelopment Agency, Planning Department, Community Development Department and Department of Building and Safety. Since arriving in Los Angeles in 1972, Griego has been involved in numerous civic and community activities. She currently serves on the boards of the Los Angeles Chamber of Commerce, KCET Public Television, Los Angeles Convention & Visitors Bureau, RLA, Town Hall of California and Scripps College.

Peggy Moore, Vice President and Sr. Manager, Home Savings of America.

For the past 17 years, Ms. Moore has served Home Savings of America in many capacities including Director of Training. In her current capacity she directs community development with the City of Los Angeles and surrounding communities. Ms. Moore is responsible for strategically managing retail deposits by coupling community involvement with deposit growth. Ms. Moore serves as a Board Member of the Rotary Club of Los Angeles, Los Angeles Boy Scouts of America, Los Angeles Convention and Visitors Bureau. Eric Schockman, Ph D., University of Southern California.

Dr. Schockman is currently a faculty member of the Department of Political Science at the University of Southern California specializing in American Politics/Urban Politics/California Studies/Ethnic and Racial Politics and Canadian Studies. He received his Ph.D. in 1982 from the University of California, Riverside. Dr. Schockman has had a progressively distinguished academic and professional career. He served most recently as the Executive Director of the Edmund G. "Pat" Brown Institute of Public Affairs. The Institute is a major interdisciplinary center for applied public policy, research and analysis of issues facing California. The institute addresses these challenges with a non-partisan, independent approach and as a facilitator of long range policy discussion and resolution. Dr. Schockman has served for over a decade as a top administrator and consultant to the California State Assembly and to the City Council of Los Angeles. Prior to committing his life to serving God and the Church as a steward and fund raiser for First AME Church, Mark was the Vice President, Commercial/Industrial National Division of Chicago Title Insurance Company. Mark completed his undergraduate work at the University of Missouri, St. Louis. He has received numerous certificates and awards including national recognition for leading the nation in membership development for the NAACP; the Mayor's community Service Award, and the Lieutenant Governor's award for community service. Mark as a frequent guest of both television and radio talk shows including Night Line, Good Morning America, The Today Show, CNN News, ABC, CBS, and NBC News and local news affiliates. He currently hosts a weekly radio program on KFI, AM 640 in Los Angeles.

HISTORY

The Hugh O'Brian Youth Foundation is dedicated to the recognition and development of leadership potential in high sophomores.

In 1958, Hugh O'Brian returned from Africa highly inspired by his visit with Dr. Albert Schweitzer. Later that year, while portraying the legendary lawman, Wyatt Earp, on television, Hugh O'Brian decided to make his own contribution to society by establishing the Hugh O'Brian Youth Foundation (HOBY). Since that time, HOBY has motivated tens of thousands of young people to realize their leadership potential by conducting annual seminars on a variety of subjects which focus around the theme of "America's Incentive System."

During the years 1958 to 1967, leadership seminars took place in Los Angeles, California, for students from that area.

In 1968, HOBY developed its annual, week-long "World Leadership Congress." Today more than 220 sophomores, representing every state and approximately 30 countries, have the opportunity to interact with nationally recognized leaders from various fields.

Since 1977, the Foundation has been involved in the development of Leadership Seminars throughout the country so that more high school sophomores may experience high-level leadership exposure on a state basis.

OBJECTIVES

- Seek out, recognize and develop leadership potential in high school sophomores in the United States and abroad.
- Encourage and assist members of this formative age group in their quest for self-identification and self-development.
- Interface these potential leaders with recognized leaders in business, science, government, education and the professions through give-and-take sessions.
- Present, through this exposure, both exploration and advocacy of the American economic incentive system and our democratic process.
- Stimulate opportunities for these young people to demonstrate their leadership abilities when they return home for betterment of community and country.

SELECTION PROCESS

Each September, the Foundation's selection process begins when the nomination materials are sent to the 20,000+ public and private high schools in the United States. All 10th graders are eligible for selection to attend one of the weekend seminars held each spring in all 50 states, Ontario, Canada, the Bahamas, Japan, and Mexico. A sophomore leader is nominated by each school and is certified by the principal.

These expense-paid workshops focus on the theme "America's Incentive System." From each HOBY Leadership Seminar, one boy and one girl are selected to represent their seminar at a week-long World Leadership Congress held in late summer. Also attending will be students from countries around the world. The 1993 WLC will be held in Columbus, Ohio.

SEMINAR RESULTS

- 93% of alumni are more willing to make decisions and be responsible for the effects of those decisions;
- 98.8% began to think about new career possibilities;
- 71% have received awards for school or community services;
- 70% are interested in careers in business and industry, law and the health sciences.
